\*Any Vendor selling food is responsible for obtaining a Food License (Permit) issued by the Central CT Health District. An application for this license can be found on the District's website at [www.ccthd.org](http://www.ccthd.org) under applications/forms/food service. The application must be submitted a minimum of two weeks prior to the event. The License will be issued the day of the event following an onsite inspection.

**General Vendor Guidelines:**

1. The market is located at Elm Ridge Park, 376 Elm Street, Rocky Hill, CT (Route 160).
2. Hours of operation are 4:00 p.m. to 7:00 p.m. (unless otherwise noted).
3. This event will take place rain or shine. Cancellation will only occur in the event of thunder/lightning.
4. Vendor check in starts at 2:30 p.m.
5. Vendors should sell only items that have been approved on the application submitted.
6. The market will provide trash cans for vendor convenience.
7. Portable restrooms are available on site.
